1. To consider a request made by the Wade House Historical Site & Wesley W. Jung Carriage House Museum (Ali Karrels Site Director) to grant a conditional use permit to allow for a driveway of more than 150' which is greater than maximum allowed within the Town of Greenbush ordinances and is 24' in width which is wider than the maximum commercial driveway permitted. The driveway will improve an existing driveway which will access a new horse arena, bleachers and related facilities to be constructed in March or April, 2022. The driveway will exit on Center Road and cross parcels #59002002290 and #59002002330 in Section 10 of the Town of Greenbush.
